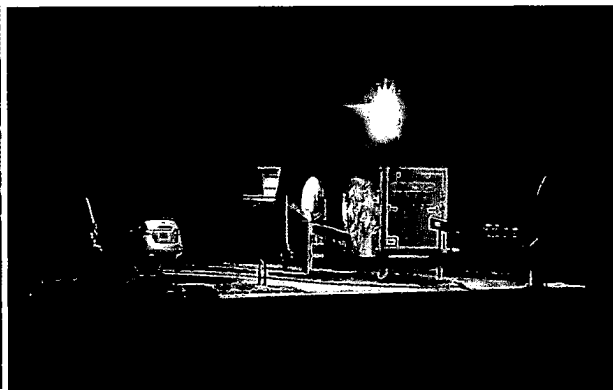

THESE PRESENTS THEREFORE are to command you with the necessary and proper assistance, as the exigencies of the occasion may demand or require, either in the daytime or the nighttime, and on any day of the week, including Sunday, to diligently search, process, video record, and photograph, as well as utilize Human Remains Detection dogs at, the herein described residence and any curtilage thereof and any vehicles thereon, for human remains, body parts, blood, bodily fluids and other serological evidence, cellular phones or mobile devices, any Xbox gaming system and accessories, notes or receipts, any drain catch basins, garbage bags, cleaning supplies, towels, sheets and other bedding, pillowcases, including but not limited to a leopard print pillowcase, a red pillowcase with stripes, and a black and grey patterned pillowcase, and if the same shall be found, to seize same and to return to a Court having jurisdiction a complete inventory of the evidence seized. The tangible evidence seized shall be maintained at the law enforcement agency as evidence within the constructive custody of the Court until further Order of a Court of competent jurisdiction. Further that all steps necessary to preserve all records deemed confidential under any theory of the law will be taken.

YOU ARE FURTHER ORDERED to bring any person arrested in connection with said property before a Court having jurisdiction of the offense.

YOU ARE FURTHER ORDERED, if no person is found in custody or control of said premises, to leave at said premises a copy of this Search Warrant and a complete inventory of

property seized.

IT IS FURTHER ORDERED that pursuant to Chapter 934 and other applicable rules and statutes and in the interest of justice, the Affidavit shall be sealed and filed with the Clerk of the Court until otherwise ordered by the Court.
