**APPLICATION FOR TEMPORARY ORDER**

COMES NOW the Petitioner and moves the Court to issue a temporary order. In support of this motion the Petitioner informs the Court as follows:


1. The Petitioner has petitioned this Court for Dissolution of Marriage. It is necessary to issue a temporary order to preserve the relative rights of the parties while this action is pending with the Court.
2. The parties' minor child is now living with Petitioner. In the best interests of the child, the Court should grant temporary sole custody of the child to the Petitioner, due to domestic violence by the Respondent against the Petitioner.
3. In the best interests of the child, the Court should grant no visitation rights to the Respondent, due to domestic violence by the Respondent against the Petitioner.
4. The Petitioner is in need of and the Respondent is capable of providing reasonable temporary child support and assistance with the future medical, health insurance and day-care expenses of the children.
5. The parties are currently separated from each other. To preserve the peace

between them, the Court should issue an order restraining the parties from bothering or harassing each other while this action is pending with the Court.

6. The Respondent should be required to pay the costs of this action.

**WHEREFORE**, the Petitioner prays the Court to grant the following relief:

- A. Grant temporary sole custody of the minor children to the Petitioner.
- B. Grant no visitation rights to the Respondent.
- C. Provide for reasonable child support, health insurance, medical and day-care expenses and issue an Income Assignment and Qualified Medical Child Support Order.
- D. Restrain the parties from bothering or harassing each other.
- E. Order the Respondent to pay the costs of this action.
- F. Grant all other just and appropriate relief.




