

## Queries cover CIA rumors, psychics, activities in home

For more than an hour last week, Springfield Police Capt. Tony Glenn answered News-Leader readers' questions about the investigation into the disappearance of three Springfield women.

Readers phoned questions to the paper, and the paper gave transcripts of the questions to Glenn.

**Caller:** You have never said anything about Susie Streeter's real father, and I had heard he was with the CIA. We were just curious if you had ever found him and if that was true.

**Glenn:** Where is Sheriff Levin's first husband and why haven't we heard anything about him?

**Caller:** Did they find other fingerprints in the house besides the neighbors' and friends? And have they located Mr. Streeter, Sheriff's first husband, and contacted him?

**News-Leader:** You have talked to Susie Streeter's father, right?

**Glenn:** Yes. He lives and is employed in the Seattle, Wash., area. He is a lifelong resident of that area and is not associated with the CIA. In answering that question is probably related to a rumor we have gotten a lot of questions about, the victim relocation program. Susie Streeter's father was involved with the CIA, so the victim-witness program around them and had to take McCall, too, because she happened to be there. I don't know where those rumors start from, but that didn't happen, so I guess.

You get a variety of rumors, and I don't mean to laugh at the questions, but some of them get a little far out.

**N.L.:** If it does show that people are involved in this case, and are trying to come up with their own theories.

**Glenn:** Sure, and how rumors can spread.

Now, the third question on here, about fingerprints. I cannot respond to, because it deals with confidential matters.

**N.L.:** That brings up another topic several readers asked about, the 19 people who went into Levin's house before the police arrived, cleaning and leaving fingerprints.

**Caller:** I've tried to imagine in my own case a similar situation and wondered what would possess me to want to clean up someone's house in a case like that. If a close friend or family member seemed to be gone under strange circumstances there are lots of things I might do, including contact the police, but I'm still just really baffled over the fact that that many people found it necessary to come clean up the house. Now I'm not at all suggesting any suspicion about any of those individuals at all, not at all. I just don't think it has ever been addressed what was in their minds to be doing this.

**Glenn:** I think a lot of people are thinking that it's rather strange for so many people to go in and do that sort of thing and then call the police. If the police could answer that question, I think that it would help a lot of people to understand in Springfield.

**Caller:** Why were all those other people in the house rearranging things before the police ever

had a chance to go through it?

**Glenn:** All 18 were friends of either Stacy or Stacy, or members of Stacy's family. They originally went over to the house because the kids were all supposed to have got together that day and gone to White Water. That is the fact that the front door was open, the cars in the driveway and what have you, initially the young adults had thought they had left to go somewhere and would be back in a short period of time. So they just kind of went in and made themselves at home, checked around, thought, Oh well, they'll be back.

So when they didn't come back for a while, they all decided to leave for a while and they did, and a few hours later they came back again. So it wasn't a case of 18 people arriving at the house and made themselves at home at all. It was a case of from the time that they first began trying to contact them until the time the police were notified, there were 18 separate individuals inside the home at some point, but never were all of them in there at one time.

**N.L.:** As one caller pointed out, some people find that kind of strange.

**Glenn:** I personally find it strange. Even though the young adults were all friends, I still found it different that they would be comfortable in going in to someone else's home, even though they had the door open. My tendency would be to think that they would call and if they didn't get an answer, then they would go over and knock on the door, maybe look in a window or something like that, but would have never gone in and spent time.

The next is here about cleaned up everything is actually an inaccurate statement. We never intended for the public to think that these individuals went into the home and physically cleaned up the home. Now there was obviously a large number of objects moved around inside the home, displaced from their original positions that they were left in, but in no manner did they clean, as is commonly associated
